No proposals will be accepted after cut-off date and time.
 - 6.2 No bids received by telegram, telex, facsimile or similar medium will be considered.
 - 6.3 Where a RFQ document is not received at the time of the RFQ closing, such a RFQ document will be regarded as a late bid. Late bids will not be considered.
 - 6.4 The Bidder is responsible for all the costs that shall be incurred in relation to the preparation and submission of the tender document.
 - 6.5 A list of all references (minimum 2) with contact details must be included in the RFQ document.
